



This is a contract entered into by ALL OUT DYNO DRAGS (hereinafter referred to as "A.O.D.D.") located at, **1771 South Lakeview Estates Wabash Indiana, 46992** (hereinafter referred to as "the Client") located at, \_\_\_\_\_, on this date, \_\_\_\_\_.

The Client hereby engages to provide services as described under "Scope and Manner of Services." A.O.D.D. hereby agrees to provide the Client with such services in exchange for consideration as described under "Payment for Services Rendered."

*Scope and Manner of Services*

A.O.D.D. will provide simulated motorcycle drag racing action, as both a participation and spectators event. Each participant will receive printed drag racing test results. A.O.D.D. will provide a public address sound system to play its song collection, and provide race commentary and other announcements as needed at the event.

*Responsibility of the Client*

The Client shall provide sufficient flat and open space to accommodate the A.O.D.D Rig and its activities. (If needed) A minimum of two 110V 20amp plugs and one person, who is familiar with motorcycles, to assist from set-up through tear down.

*Payment for Services Rendered*

Client agrees to pay the sum of **50% of total cost** as a booking fee for services provided during event conducted **Date and Time.** \_\_\_\_\_ -

(If needed) Client agrees to provide lodgings in the form of one, double-bed hotel rooms for **Date** \_\_\_\_\_

Client agrees to pay a travel surcharge of **N/A (included in booking fee).**

Client agrees to include A.O.D.D. as an additional insured party on all event insurance and to provide A.O.D.D. with proof of same no later than 7 days prior to the start of the event.

Client agrees to pay 50% of the booking fee as well as 100% of the travel surcharge as deposit upon completion of a signed contract. Client agrees to provide, at least 7 days prior to the start of the event, confirmation number for lodging. A.O.D.D. will be responsible for incidentals. **Payment is due in full when the A.O.D.D. arrives on site to begin setup, prior to the start of the event.**

If an event is cancelled by the Client, for any reason, notice must be given to A.O.D.D. prior to enroute to the site. In such case, Client will forfeit deposit. If an event is cancelled by A.O.D.D the Client will receive a full refund of the deposit within 10 business days of the cancellation and A.O.D.D. shall not be responsible for any advertising expenses or lost revenue due to the cancellation. Once on site, if A.O.D.D. is unable to provide services during all or part of the event due to mechanical problems, a refund of the booking fee shall be provided to the client on a pro-rata basis.

*Insurance*

Upon completion of a signed contract, A.O.D.D. agrees that it will contact its liability insurance carrier prior to the Event and list the Client as an additional insured on its insurance policy. A.D.R. shall furnish the Client with a Certificate of Insurance that provides a minimum of One Million Dollars (\$1,000,000.00) of insurance coverage which shall cover losses related to the specific activities of A.O.D.D. Coverage shall continue throughout the duration of the event. A.O.D.D. shall have full control over the use of the drag race simulator and may refuse service at any time if A.O.D.D. feels weather or other conditions make operation unsafe. A.O.D.D. may also refuse, at any time, service to any participant it feels as a risk to themselves, spectators, crew or the A.O.D.D.'s equipment. In either case, no refunds will be given.

All participant must complete the A.O.D.D. release form before participation.
